# HTG Purpose (as per Constitution)

- To encourage and coordinate the efforts of individuals, municipalities and trail user groups in Simcoe County **to develop and maintain a network of trails and greenways for recreational, educational, environmental and ecological uses;**
- To promote and encourage the **conversion of abandoned rail-lines** into trails and/or linear greenways for the enjoyment of the community;
- To protect and enhance the **linear greenway network** as natural environment areas and wildlife corridors;
- To establish a constructive **relationship with adjacent landowners and authorities from all levels of government to secure and maintain trails to provide a healthy and affordable recreational opportunity for local residents and visitors to Huronia;**
- To educate the general public and trail users in order to encourage responsible and shared use of trails and greenways;
- To create public awareness of, and public support of **HTG and its objects** in that supporters, volunteers and/or members are required for local trail management groups, and for other activities to achieve HTG objects;
- To promote and **provide funds for these objects, with emphasis on trail building, upgrading and maintenance for improved public enjoyment and safety**



## Governance of the organization

- Minimum of 8 members, max of 20
- Term: 1 year, up to a max. of 8 consecutive years
- Directors shall be elected at the AGM by the membership at large and by representatives of member organizations, boards and businesses.
- Directors who fail to carry out their duties, or fail to attend 4 consecutive meetings of the board, may be asked to resign at the discretion of the board.
